

## Earth Hour Contest

### Terms & Conditions:

1. The Contest begins on 27<sup>th</sup> March 2021 and ends at 11.59pm on 31<sup>st</sup> March 2021 (“Contest Period”)
2. Maevi Sdn. Bhd. may at its sole and absolute discretion extend the Contest Period at any time without any prior notice to any party (“the Extended Period”). Unless an Extended Period is announced, any entries received after the end of the Contest Period (due to any reason howsoever and/or whatsoever arising) shall be disqualified. Any participation in the Contest during the Extended Period (if any) shall be governed by these terms and conditions (“Terms and Conditions”) which shall remain in full force and effect.
3. The Contest is open to Malaysian citizens aged 18 years old and above who had at least one (1) Maevi devices or more.
